### Purpose of this Privacy Notice

This Privacy Notice aims to give you information on how we collect and process your personal data, including any data you may provide through our website [www.blvsecurities.com](http://www.blvsecurities.com), email communications, or in connection with our private placement services. ### Data We Process About You

Personal data means any information about an individual from which that person can be identified. It does not include data that has been anonymized such that a person's identity is removed. We may collect, use, store, and transfer different kinds of personal data.

The categories of personal data which we process include:

- **Contact Data:** Names, job titles, and other identifiers, together with addresses, email addresses, and telephone numbers.
- **Client Data:** Personal data in connection with providing our private placement services. This includes data about key contacts and employees within business clients, bank account details, salary details, and employment history. Special category data may be collected if required.
- **Third-Party Data:** Data about professionals and counterparties, including contact details and information about trustees and beneficiaries.
- **Technical Data:** Internet protocol (IP) addresses, login data, browser type and version, time zone setting and location, browser plug-in types and versions, operating system and platform, and information about how you use our website and services.
- **Marketing Data:** Marketing and communication preferences, networking and business development data such as employment history and personal interests.

### How Personal Data is Collected

We use different methods to collect data from and about you, including:

- **Direct Interactions:** When you or your organization seek advice or provide services to us, or when you communicate with us via email, phone, or through our website.
- **Automated Technologies:** When you visit or interact with our website, including the use of cookies.
- **Third Parties:** From third parties and publicly available sources.

### Fair and Lawful Processing

We only collect, use, disclose, or otherwise process your personal data where it is fair and lawful to do so. We may ask for explicit consent when required by local law. If you fail to provide the required data, we may not be able to fully perform our obligations.
